Social Responsibility Plan on Tuesday, February 7, by transporting, via bus, more than 80 of their employees to Blind Children's Learning Center in Santa Ana, Calif. to spend the morning cleaning toys, painting furniture and assisting visually impaired children. In addition, a team of TowerJazz engineers created a blueprint for a future play area.

Many of the employees worked one-on-one with the children in the classrooms and on the playground. They found it enlightening to experience that blind and visually impaired children can learn the same skills as sighted children, they just learn through different methods that focus on sound and touch.

Its goal is to provide opportunities for under-represented populations, under-privileged children and support educational programs focusing on science, mathematics and engineering.

I was extremely proud of not only the number of our employees who volunteered at Blind Children's Learning Center, but also the level of their commitment and participation," said Russell Ellwanger, Chief Executive Officer, TowerJazz.
